ORDINANCE 20, SECTION 11 provides that: "...Every holder of a permit to conduct a taxicab business in the City of Nederland shall have each and every taxicab used in his business inspected once each sixty (60) days, and shall file with the City Secretary on or about the first day of each second month, a statement in writing signed by a competent resident mechanic showing that he has inspected such vehicle, the date of such inspection, the license number of such vehicles, the name of the permittee and the serial number of his permit; and that the lights, brakes and steering apparatus of all such vehicles so inspected by him are in good mechanical condition..."
